WHAT'S IN IT FOR ME MEMBERSHIP AGREEMENT

Whatsinitforme.com, LLC, aka What's In It For Me, is a business process that develops high quality, Class A sales referrals, with a Buyer-validated and approved "Intent to Buy," together with an "Invitation to Call" by qualified Sales Professionals, incorporating the voluntary submission of information by anyone with the knowledge of someone else's, or their own, intent to buy a product or service. A sales lead developed from this business process is referred to as an APIX Sales Referral. The methods used in developing the APIX Sales Referral is a patent pending business process with the goal of achieving the "Maximum Competitive Effect" for our Buyer Members and perfect sales leads for our Sales Professional and Vendor Members (collectively, the "Process").

In order to take part and benefit from the process (as defined below), You must read and accept all of the terms and conditions in, and linked to this Membership Agreement (this "Agreement"), which may be modified by What's In It For Me from time to time at our sole discretion. All modifications will be posted on www.whatsinitforme.com (our "Website") and such modifications will become effective immediately upon the posting thereof. It is your responsibility to review this Agreement on a regular basis to keep yourself informed of any modifications. We strongly recommend that as You read this Agreement, You also access and read the linked information. By accepting this Agreement, You also agree that Your use of some of What's In It For Me-branded websites, website pages or other websites we operate, may be governed by separate membership agreements and privacy policies. BY ACCEPTING THE TERMS OF THIS AGREEMENT, YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD AND AGREE TO BE BOUND BY ALL OF THE TERMS, CONDITIONS AND NOTICES CONTAINED IN THIS AGREEMENT JUST AS IF YOU HAD SIGNED THIS AGREEMENT.

TERMS OF USE

1. WHAT'S IN IT FOR ME PROCESS

What's In It For Me develops and markets high quality sales referral information and offers the same for sale to Sales Professionals and Vendors with the participations and approval of potential Buyers of products and services and Information Partners, who share information about other people's, and their own, "intent to buy." The Process is currently comprised of three entities or membership types, all of which require active membership in What's In It For Me. The three types of members included in this membership agreement are: (1) Information Partner Members ("Information Partner," or "IP") (2) Buyer Members ("Buyer") and (3) Sales Professional and Vendor Members (Vendors), described as follows:

- (1) Information Partners are members who voluntarily report information pertaining to other individuals and companies who are in the market, or soon to be entering the market, to purchase certain products and services that are approved and offered on the Website. Information Partners can earn commissions for reporting valid information regarding someone else's intent to purchase products and services that are represented on our Website. Information Partners may submit this information anonymously or may choose to have their identity revealed to potential Buyer Members and Sales Professional and Vendor Members, at their sole discretion. Information Partners may earn commissions when Sales Professionals and Vendors purchase the APIX Sales Referral originated on the Website by them. Information Partners may also submit information about their own pending purchase of a product or service and earn additional commissions as a "Buyer Member."
- (2) Buyer Members are companies or individuals who have entered, or are about to enter the market to purchase products and services represented on our Website. Buyers are encouraged to validate and approve information submitted by Information Partners and can earn commissions with the completion of their purchase, if purchased from a Sales Professional or Vendor Member, who purchased the APIX Sales Referral from our Website. Buyers may submit their own intent to purchase information as an Information Partner and receive additional commissions.
- (3) Sales Professional and Vendor Members are sales people representing a company, product or service, either as an employee of that company or an independent representative; Vendors are those companies and individuals who provide products and services to customers without sales professionals representing them, such as many trades, craft and professional services. Sales Professionals and Vendors will receive notification of the existence of an APIX Sales Referral for their sales territory and will be offered an opportunity to purchase the identity and details of the referral. Upon the purchase of an APIX Referral, the identity and specific information about the Sales Professional or Vendor, and their company and/or product and service, will be immediately forwarded to the Buyer Member.

2. REGISTRATION INFORMATION

As a condition of Your use of the Process, You agree to (a) provide What's In It For Me with true, accurate, current and complete information as prompted by the What's In It For Me's registration forms when registering for or using the Process and (b) update and maintain the truthfulness, accuracy and completeness of such information.

3. MINIMUM AGE

If You are under the age of eighteen (18), You are prohibited from using or registering for the Process.

4. USE VOID WHERE PROHIBITED

Membership in the Process is void where prohibited.

5. PRIVACY POLICY

What's In It For Me has established a privacy policy to explain to You, and other users, how Your personal information is collected and used. This privacy policy is located at www.whatsinitforme.com/privacypolicy.htm.

6. PROCESS FEES AND BILLING METHODS; AUTOMATIC RENEWAL

What's In It For Me will charge our Vendors a membership fee in order to provide access to the Process (the "Membership Fee") and the opportunity to purchase APIX Sales Referrals. As a Vendor, you acknowledge that What's In It For Me reserves the right, at any time, to modify its Membership Fees and billing methods. Membership Fees for access to the Process may be made either on a monthly or annual basis. Once a membership is purchased, you will be granted access to the Process for one subscription within a Product Category and market (by County and State) selected by You. You may purchase access to additional product category subscriptions within a market ("Additional Product Categories") on the terms and subject to the conditions set forth below. Annual Membership Fees and Additional Product Categories may only be paid in advance by cash, check, credit card, debit card or PayPal. The terms of such monthly, annual and Additional Product Category membership plans are listed below.

From time to time, What's In It For Me may accumulate raw data submitted by an Information Partner that has not been validated by potential Buyers. This information may or may not be accurate with regard to a Buyer's true intent to purchase a product or service. This accumulated information may be offered for sale as "grab bag" sales tips but in no way is represented by What's In It For Me as valid sales leads. "Grab bag" information may contain duplicate leads and erroneous information and is sold "as is" with no guarantees or assurances of its completeness or accuracy and no refunds will be authorized.

UNLESS SUCH MEMBERSHIP PLAN IS CANCELLED OR TERMINATED AS PROVIDED BELOW, ALL MEMBERSHIP PLANS WILL BE AUTOMATICALLY RENEWED UPON THE TERMS SET FORTH BELOW.

Monthly Payment Plan

IF YOU SELECT THE MONTHLY PAYMENT PLAN, EACH MONTH WHAT'S IN IT FOR ME WILL AUTOMATICALLY RENEW YOUR MEMBERSHIP ON A MONTH-TO-MONTH BASIS AT THE MEMBERSHIP FEE (AS SUCH MEMBERSHIP FEE MAY BE MODIFIED AS PROVIDED ABOVE) USING THE CREDIT CARD, DEBIT CARD OR OTHER PAYMENT INFORMATION ON FILE WITH WHAT'S IN IT FOR ME. Each monthly renewal payment will take place on or about Your

expiration date. If the renewal of Your monthly membership fails for any reason, we will attempt to process Your renewal for a period up to sixty (60) days in accordance with our standard renewal practices then in effect (which may be modified from time to time by What's In It For Me). Except as otherwise required by applicable law, You agree that What's In It For Me will not provide You with any notices prior to each monthly renewal payment.

Annual Payment Plan:

IF YOU SELECT THE ANNUAL PAYMENT PLAN, WHAT'S IN IT FOR ME WILL AUTOMATICALLY RENEW YOUR ANNUAL MEMBERSHIP FOR ONE YEAR AT THE MEMBERSHIP FEE FOR ANNUAL MEMBERSHIPS (AS SUCH MEMBERSHIP FEE MAY BE MODIFIED AS PROVIDED ABOVE) USING THE CREDIT CARD, DEBIT CARD OR OTHER PAYMENT INFORMATION ON FILE WITH WHAT'S IN IT FOR ME. Such annual renewal payment will take place on or about the 1st of the calendar month in the month in which Your annual membership expires. If the renewal of Your annual membership fails for any reason, we will attempt to process Your renewal for a period up to sixty (60) days in accordance with our standard renewal practices then in effect (which may be modified from time to time by What's In It For Me). Except as otherwise required by applicable law, You agree that What's In It For Me will not provide You with any notices prior to each annual renewal payment.

Additional Product Category Plan for Sales Professionals and Vendors:

Upon purchase of a membership, the initial Product Category selected by You is considered Your "primary" subscription. You may purchase access to additional Product Categories through Your membership by using the Additional Product Categories List feature located on the Website. In order to purchase and obtain access to Additional Product Categories, Your primary subscription must be active and in good standing. IF YOU PURCHASE ANY ADDITIONAL PRODUCT CATEGORIES, AT A TIME AFTER YOUR PRIMARY CATEGORY WAS PURCHASED, WHAT'S IN IT FOR ME WILL AUTOMATICALLY CHARGE YOUR METHOD OF PAYMENT ON A MONTH TO MONTH BASIS. RENEW EACH ADDITIONAL PRODUCT CATEGORIES FOR ONE YEAR AT THE MEMBERSHIP FEE FOR SUCH ADDITIONAL PRODUCT CATEGORIES (AS SUCH MEMBERSHIP FEE MAY BE MODIFIED AS PROVIDED ABOVE) USING THE CREDIT CARD, DEBIT CARD OR OTHER PAYMENT INFORMATION ON FILE WITH WHAT'S IN IT FOR ME. The renewal payments will take place on or about the expiration date of Your Additional Product Categories subscription. If the renewal of any of Your Product Category subscriptions fails for any reason, we will attempt to process Your Product categories renewals for a period up to sixty (60) days in accordance with our standard renewal practices then in effect (which may be modified from time to time by What's In It For Me). Except as otherwise required by applicable law, You agree that What's In It For Me will not provide You with any notices prior to each renewal payment

for any Product Categories. In the event your primary subscription is not renewed or terminated for any reason, any Additional Product Categories subscriptions purchased will be automatically terminated.

Membership Renewals

If You received a free offer to access subscriptions in the Process, What's In It For Me, will renew your membership at the Membership Fee (as such Membership Fee may be modified as provided above) using the credit card, debit card or other payment information on file with What's In It For Me. All existing memberships will be renewed at the Membership Fee (as such Membership Fee may be modified as provided above) and will include access to all subscriptions unless You otherwise elect to cancel access to a particular subscription in accordance with the provisions set forth below.

If you received a free offer for Your Additional Product Categories, What's In It For Me will provide you notice via email prior to renewing the Additional Product Categories at the Membership Fee (as such Membership Fee may be modified as provided above) using the credit card, debit card or other payment information on file with What's In It For Me.

Subscriptions IF YOU DECIDE TO CANCEL ACCESS TO A SUBSCRIPTION OR SUBSCRIPTIONS INCLUDED IN THE PROCESS, YOUR CANCELLATION REQUEST MUST BE RECEIVED NO LATER THAN 5:00 P.M. (MANSFIELD, OHIO, OHIO LOCAL TIME) ON OR BEFORE THE THIRTIETH (30TH) DAY AFTER YOUR RENEWAL PAYMENT IS MADE. YOU MAY CANCEL ACCESS TO A SUBSCRIPTION OR SUBSCRIPTIONS BY PROVIDING WHAT'S IN IT FOR ME WITH NOTICE OF YOUR DESIRE BY CONTACTING WHAT'S IN IT FOR ME BY UNITED STATES POSTAL SERVICE, CERTIFIED MAIL, FIRST CLASS MAIL, POSTAGE PRE-PAID, AT P.O. BOX 1625, MANSFIELD, OHIO 44901, BY FACSIMILE AT (419) 524-2107 OR BY EMAIL AT

7. ACCOUNT SECURITY

What's In It For Me will assign You a user ID and a password when You register. Your user ID and password may only be used by You. You are solely responsible for maintaining and protecting the confidentiality of Your user ID and password, and are fully responsible for all activities that occur under Your user ID and password.

8. LIMITED LICENSE TO WEBSITE

By agreeing to the terms and conditions of this Agreement, What's In It For Me grants You a limited license to access and use the Process for Your personal purchase decisions. You acknowledge and agree that You will not access, reproduce, duplicate, copy, sell, re-sell, visit or otherwise exploit for any commercial, educational (or any other non-personal) purpose any of the referral information, reviews and ratings and any content, without the express written consent of What's In It For Me.

9. RULES GOVERNING MEMBERS' PARTICIPATION AS INFORMATION PARTNERS

In order for You to submit information regarding someone else's intent to buy a product or service represented by the Website, You acknowledge and agree that:

(a) all of the information you submit about someone else's intent to buy, or your own intent to buy any product or service on the Website must be true and accurate. Although the Scope

of Work questions on the lead form may vary from what the actual prospective Buyer would confirm, the basis for your lead submission activity is that you have certain knowledge that a potential Buyer has expressed an intention to buy a particular product or service. Knowingly submitting fraudulent information and creating a bogus lead is means for revocation of your membership for all time. No appeals process is currently in place for What's In It For Me members who violate this rule.

- (b) any commissions you may earn for submitting the sales lead information is dependent on three steps being completed as part of the Process. Those three steps are:
 - (i) You being the first Information Partner to submit this lead, thus creating an APIX Sales Referral project,
 - (ii) the prospective Buyer Member must validate and confirm this project,
 - (iii) Sales Professional Members must purchase the completed APIX Sales Referral from What's In It For Me.
- (c) You may submit sales leads as an Information Partner anonymously. However, if you choose to waive your desire for anonymity, you may designate your intent to reveal your identity during the completion of the lead form. Although reasonable people may conclude that by You submitting this lead information, You are providing a benefit and service to prospective Buyers and Sales Professional Members alike, You will hold What's In It For Me harmless for any consequences to you, your employment or your relationship with other Members if your identity is disclosed.
- (c) As an Information Partner You will accumulate commissions in your membership dashboard located in your member profile. Disbursements of commissions will be completed upon your request for payment from the dashboard. No disbursement will be made for an amount less than \$25.00 US.
- (d) For residents of the U.S., if you request payment of any amount earned in excess of \$600.00 in any calendar year, you will be required to submit a completed IRS Form W9, which will be sent to you by the Website. No disbursements of payments in excess of \$600.00 US in any given calendar year will be paid unless a valid W9 Form has been received and filed by What's In It For Me. W9's can be submitted via fax at (419) 524-2107 or by U. S. mail to P.O. Box 1625, MANSFIELD, OHIO 44901.
- (e) all tax filing and reporting is the sole responsibility of our Members.
- 10. RULES GOVERNING MEMBERS' PARTICIPATION AS A SALES PROFESSIONAL or VENDOR

- (a) as a Sales Professional or Vendor Member, you will maintain a valid credit card, debit card or other approved payment method on file with What's In It For Me.
- (b) You may view as many "Scopes of Work" as are available for the Primary Product Category and Additional Product Categories that you have selected and as defined in Your user profile.
- (c) You may purchase as many APIX Sales Referrals as are presented to you by the Website.
- (d) You MUST provide a satisfaction rating of the lead information and Information Partner that originally submitted the sales lead. This rating is critical in the Website's ability to identify and eliminate those Members submitting bogus leads. It is also a means for What's In It For Me to reward those Information Partners that consistently provide high quality and dependable sales leads.
- (e) When a sale is consummated, Buyer Members are required to report to What's In It For Me the identity of the successful Sales Professional or Vendor Member completing the sale. It is Your responsibility to confirm the completed sale transaction with What's In It For Me, by responding to an email to that effect, sent by the Website.

11. RULES GOVERNING MEMBERS' PARTICIPATION AS A BUYER OF PRODUCTS AND SERVICES

As a Buyer participating in the Process, you agree to certain specific rules designed to establish and maintain the highest degree of professionalism and ethics in the buying and selling process. Additionally, as a Buyer Member, you may earn substantial commissions collected by What's In It For Me in the form of the APIX Sales Referrals that you help create and sell to our Sales Professional and Vendor Members. As such, you agree:

- (a) all information provided by you will be true, accurate and complete in all respects.
- (b) in order to receive commissions by taking part in the Process, you will report to What's In It For Me when you have consummated a sale with a What's In It For Me Sales Professional or Vendor Member and will identify that member by return email to What's In It For Me when requested.
- (c) You will complete and return, via email, a Product Purchased Satisfaction Report when requested.
- (d) You will complete and return, via email, a Vendor Satisfaction Report when requested.

The information collected in the Product and Vendor satisfaction reports will be made available to other Buyer Members purchasing similar products and services in the future.

12. PUBLICATION AND DISTRIBUTION OF CONTENT

What's In It For Me does not guarantee the accuracy, integrity, quality or appropriateness of any Content transmitted to or through the Process. You acknowledge that What's In It For Me simply acts as a passive conduit and an interactive computer service provider for the publication and distribution of its Content.

As a Buyer Member of What's In It For Me, you understand and acknowledge your responsibilities governing your conduct as an owner, manager, director, government employee or board of director's member of any publicly traded company and as such, You agree to hold What's In It For Me harmless in all respects regarding your participation in the Process.

13. CONTENT LICENSE

Although What's In It For Me does not claim ownership of any of the information received by Information Partner Members and Buyer Members, You automatically grant, and You represent and warrant that you have the right to grant, to What's In It For Me an irrevocable, perpetual, non-exclusive, fully paid, worldwide license to use, copy, perform, display, reproduce, adapt, modify and distribute such Content and to prepare derivative works of, or incorporate into other works, such Content, and to grant and to authorize sublicenses (through multiple tiers) of the foregoing. In addition, by providing What's In It For Me with Content, You automatically grant us all rights necessary to prohibit the subsequent aggregation, display, copying, duplication, reproduction or exploitation of the Content on our Website by any other party.

You understand that all Content posted on, transmitted through or linked through the Process, is the sole responsibility of the person from whom such Content originated. You understand that What's In It For Me does not control, and is not responsible for Content made available through the Process, and that by using the Process, you may be exposed to Content that is inaccurate, misleading, offensive or untrue.
